- A minimum of 5 flight hours within 90 days preceding the award application deadline. Two hours may be in an Advanced Aviation Training Device (AATD) or Flight Training Device (FTD) appropriate to the rating sought with CFI logbook entry.

### HOW IS THE SCHOLARSHIP PAID?

The financial distributions are paid out for each goal, listed below, successfully completed within 12 months of receiving the award. The indicated amounts will be paid directly to the qualified instructor or flight school on the student pilot's behalf. A qualified instructor is one recognized by the VC99s with a CFI certificate in good standing.

#### Aviation Goals for Private Pilot/Sport Pilot

- Kick start payout..... \$500
- After 10 additional hours of training\* .. \$500
- FAA written examination (passed) ..... \$500
- First solo flight ..... \$500
- Solo long cross country ..... \$500
- FAA check ride (passed) ..... \$500

#### Aviation Goals for Balloon/Glider Pilot

- Kick start payout ..... \$500
- After 10 additional hours of training\* ... \$500
- FAA written examination (passed) ..... \$500
- First solo flight ..... \$1,000
- FAA check ride (passed)..... \$500

Applicants who have completed one or more of the aviation goals prior to being awarded the scholarship will qualify for payment for all goals accomplished. To request payment upon completion of one of the aviation goals, winner must provide a written request to the Scholarship Committee with a copy of logbook showing achievement, the committee will then notify the treasurer to distribute the funds. In the event of unforeseen circumstances where winner is unable to complete the aviation goals within one year, one six (6) month extension may be granted upon progress review. A written request must be received by the Ninety-Nines Scholarship Committee before the 12 month period after receipt of the scholarship.

### SELECTION

Applications are accepted beginning two weeks prior to the deadline. The scholarship committee does not determine winners. scholarship winner(s) will be chosen by an independent panel of outside judges on a point system. Consideration is given for applicant's participation in activities that support women in aviation.

### WHO WE ARE

The Ventura County Ninety-Nines are a Chapter of The Ninety-Nines International organization of women pilots. The membership is comprised of both private and career women pilots. The Chapter holds general membership meetings on most third Tuesday evenings each month. These meetings include "plane talk," camaraderie, and educational speakers. See the bi-monthly newsletter "The Flyer" under the News tab at VC99s.org for upcoming meetings, fly-outs and special activities. Female student pilot members of The Ninety-Nines may join the Ventura County Chapter in the "Female Student Pilot" category and be eligible to access information and communication through our VC99s group membership email and forum. We raise funds for our scholarships through a number of different activities including the annual Wings Over Camarillo Air Show in August, winter aviation classes, and other activities. Other chapter events are listed on the website.

- Good physical health and am at least 17 years of age as of application due date. (If under 18, written parental permission is required.)
- A current FAA Student Pilot Certificate at the time of application or have a pending Student Pilot Certificate application in IACRA.
- A valid Third Class Medical Certificate if required for the certificate sought, or if medical not yet obtained, I understand that a medical certificate will be required to receive funds if working towards a private certificate.
- Reside or work in Ventura County, or I train at one of the Ventura County airports (CMA, OXR, SZP or NTD).
- Within 90 days of the scholarship deadline, logged 5 hours of certified flight time in aircraft (not including ground training). Two hours may be in an Advanced Aviation Training Device (AATD) or Flight Training Device (FTD) appropriate to the rating sought with CFI logbook entry.
- Confirmed that all completed pages of my required logbook are signed and hours tallied.

#### **I have included in my packet:**

- Completed current application form.
- Appropriate copies from my log book showing the required 5 flight hours in the past 90 days from application deadline.
- A copy of my medical certificate if required.
- One page personal essay font size Arial 11 or larger addressing the required topics.
- Copy of student pilot certificate (front and back).
- Signed parental consent, if under 18 years.
